APPOINTMENT OF MEETING CHAIRMAN 22 The Board appointed District Counsel Vivek Babbar as the Chairman to run the Landowners 23 24 Election. 25 3. ANNOUNCEMENT OF CANDIDATES/CALL FOR NOMINATIONS 26 27 District Counsel explained the election process and stated the three eligible seats. The candidates 28 were announced: Jessica Ellis, Eugenia Lynch, Penny Clark, and Adam Newell. 29 30 31 4. ELECTION OF SUPERVISORS 32 The ballots and proxies were collected, and the votes were tabulated. District Counsel announced 33 the results: Eugenia Lynch received the highest number of votes at 162 and will have Seat 5 with a 34 four-year term, Penny Clark received the second highest number of votes at 130 and will have Seat 35 1 with a four-year term, and Jessica Ellis received the third highest number of votes at 22 and will 360 have Seat 5 with a two-year term. Adam Newell received 5 votes and was not elected. 37 38 District Counsel explained the legal requirements to the new Supervisors as well as the Sunshine 39 Laws and filing the paperwork with the County. 40
